In this privacy notice, if we refer to:

- Website: We are referring to any website of ours that references or links to this policy.
- Discord Bot: We are referring to any discord bot of ours that references or links to this policy.

The purpose of this privacy notice is to explain to you in the clearest way possible what information we collect, how we use it, and what rights you have in relation to it. If there are any terms in this privacy notice that you do not agree with, please discontinue use of our Services immediately.

Please read this document (privacy policy) carefully, as it will help you understand what data we collect, and how we use it.

## 1. WHAT INFORMATION DO WE COLLECT?

***In Short:*** We collect personal information that you provide to us.

We collect personal information that you voluntarily provide to us when you register on the Website/Discord Bot, express an interest in obtaining information about us or our products and Services, when you participate in activities on the Website/Bot (such as by posting messages in our online forums or entering competitions, contests or giveaways, adding the discord bot to your server) or otherwise when you contact us.

The personal information that we collect depends on the context of your interactions with us and the Website, the choices you make and the products and features you use. The personal information we collect may include the following:

***Personal Information Provided by You.*** Your Discord Name, Your Discord Tag, Your Discord ID, Discord Avatar, Discord Avatar URL, (if server owner): Server Name, Server ID, Server Member Count

***Payment Data.*** We do not handle payments, we use a third-party application: stripe. for more information about stripe's privacy policy check out their privacy policy: <https://stripe.com/privacy>

## 2. HOW WE USE YOUR INFORMATION?

In Short: We process your information for purposes based on legitimate business interests, the fulfillment of our contract with you, compliance with our legal obligations, and/or your consent.

We use personal information collected via our Website for a variety of business purposes described below. We process your personal information for these purposes in reliance on our legitimate business interests, in order to enter into or perform a contract with you, with your consent, and/or for compliance with our legal obligations. We indicate the specific processing grounds we rely on next to each purpose listed below.

We use the information we collect or receive:

- ***To complete a bots task.*** For the bot to continue it's task it needs specific information such as an avatar command. The bot needs to contact the Discord API (thru discord.js API) to get the user's avatar URL
- ***For Feedback & Errors.*** When there's a error/or a bug the bots console/terminal gets a report/review of the bug which might include (depending on command) your user ID
- ***For Statistics.*** Bot Owners of Yono ("us") need data on what servers the bot is in, server count, member count, server id. (This command/data is only available to the Owners of the bot)
- ***For Bot Status.*** In our bots status, the number of servers the bot is in is displayed, but the servers name, servers owner, server id is not stated to the public.

## 3. WILL YOUR INFORMATION BE SHARED WITH ANYONE?

**In Short:** We only share information with your consent, to comply with laws, to provide you with services, to protect your rights, or to fulfill business obligations.

We may process or share your data that we hold based on the following legal basis:

- **Consent:** We may process your data if you have given us specific consent to use your personal information for a specific purpose.
- **Legitimate Interests:** We may process your data when it is reasonably necessary to achieve our legitimate business interests.
- **Performance of a Contract:** Where we have entered into a contract with you, we may process your personal information to fulfill the terms of our contract.
- **Legal Obligations:** We may disclose your information where we are legally required to do so in order to comply with applicable law, governmental requests, a judicial proceeding, court order, or legal process, such as in response to a court order or a subpoena (including in response to public authorities to meet national security or law enforcement requirements)
- **Vital Interests:** We may disclose your information where we believe it is necessary to investigate, prevent, or take action regarding potential violations of our policies, suspected fraud, situations involving potential threats to the safety of any person and illegal activities, or as evidence in litigation in which we are involved.

More specifically, we may need to process your data or share your personal information in the following situations:

- **Business Transfers.** We may share/or transfer your information with, or during negotiations of, any merger (merging with other companies), sale of company assets, financing, or acquisition of all or a portion of our business to another company.

## 4. HOW WE KEEP YOUR INFORMATION SAFE?

**In Short:** We aim to protect your personal information through a system of organizational and technical security measures.

We have implemented appropriate technical and organizational security measures designed to protect the security of any personal information we process. However, despite our safeguards and efforts to secure your information, no electronic transmission over the Internet or information storage technology can be guaranteed to be 100% secure, so we cannot promise or guarantee that hackers, cybercriminals, or other unauthorized third parties will not be able to defeat our security, and improperly collect, access, steal, or modify your information. Although we will do our best to protect your personal information, transmission of personal information to and from our Website is at your own risk. You should only access the Website within a secure environment.

## 5. WHAT ARE YOUR PRIVACY RIGHTS

In Short: In some regions, such as the European Economic Area (EEA) and United Kingdom (UK), you have rights that allow you greater access to and control over your personal information. You may review, change, or terminate your account at any time.

In some regions (like the EEA and UK), you have certain rights under applicable data protection laws. These may include the right (i) to request access and obtain a copy of your personal information, (ii) to request rectification or erasure; (iii) to restrict the processing of your personal information; and (iv) if applicable, to data portability. If you are a resident in the EEA or UK and you believe we are unlawfully processing your personal information, you also have the right to complain to your local data protection supervisory authority.
